**CALL U.S. ATTORNEY PATRICK FITZGERALD** at [312-353-5300](tel:312-353-5300), then dial 0 (zero) for operator and ask to leave a message with the Duty Clerk — demand that he stop the grand jury witch hunt. **CALL OR EMAIL PRESIDENT OBAMA AND ATTORNEY GENERAL ERIC HOLDER** with the 3 demands listed on this page.
